upcoming Projects

The pool is scheduled to be open mid-June. The pool shed roof is currently being replaced. Its replacement is a shared cost with building #1, as is pool maintenance. Bug zappers are scheduled to be installed as well.

TKG is in the process of securing quotes for paving of the upper parking lot, including replacement of the wooden curbs, as well as the pavement in front of the building.

Shakes on rear of building outside unit 7 and above the roof on the front porch should be completed this summer.

Proctor Gas

We were recently given notice by Proctor Gas (PG) that they will no longer be able to provide us with gas or service our heaters. We are not the only condo association effected by this change. Due to current state regulations, they no longer will work with large contracts. Steve Lydon has worked diligently to acquire a new provider, Keyser Energy. Our contract ends at the end of June and PG assures us they will work with Keyser Energy to ensure a smooth transition, which is scheduled to take place by months end.
