Project updates

Gas Shut-off

As you are aware, an email was sent out to all owners that the propane to the building has been shut-off. This means that the dryers are not working as they are gas dryers. Please know that there was no imminent danger; however, there was a minor concern determined by Keyser Energy, our propane provider.

Our property manager (PM) is working to resolve the issue, and at this time we cannot say when the gas will be back on; however, please know that this is a top priority for the Board and our property manager. At some point soon our PM will need to enter all units to shut off all pilot lights before turning the gas back on. He will then need to enter units if you want him to turn your pilot lights back on.

In addition, we will be switching to Dead River Propane as our provider of gas and services. We thank you for your understanding and patience with this issue. Again, if you have any questions please contact us.
